- no restriction as to the qualification of a proxy.
- A member shall be entitled to appoint more than one (1) proxy to attend, participate, speak and vote in his stead.
- Where a member appoints more than one (1) proxy, the appointment shall be invalid unless he specifies the proportions of his holdings to be represented
- Where a member is an authorised nominee as defined under the Securities Industry (Central Depositories) Act, 1991, it may appoint at least one (1) proxy in respect of each securities account it holds with ordinary shares of the Company standing to the credit of the said securities account.
- Where a member is an exempt authorised nominee as defined under the Securities Industry (Central Depositories) Act, 1991, which holds ordinary shares in the Company for multiple beneficial owners in one securities account ("Omnibus Account"), there is no limit to the number of proxies the exempt authorised nominee may appoint in respect of each Omnibus Account it holds. If more than one (1) proxy is appointed, the appointment shall be invalid unless the exempt authorised nominee specifies the number of shares to be represented by each proxy.
- In the case of a corporate member, the instrument appointing a proxy must be executed under its Common Seal or the hand of its attorney.

The Proxy Form can be electronically submitted/lodged via Tricor's TIIH Online at https://tiih.online. Please refer to the Administrative Guide for the procedures on electronic lodgement of proxy form.

For the purpose of determining a member's eligibility to attend and vote at the EGM, the Company shall obtain a General Meeting Record of Depositors as at 28 July 2022 from Bursa Malaysia Depository Sdn Bhd in accordance with Clause 73 of the Company's Constitution and Paragraph 7.16(2) of Bursa Malaysia's Main Market Listing Requirements. Only depositors whose names appear therein shall be entitled to attend in person or appoint proxies to attend and/or vote on their behalf at the EGM.
